Dear Parents,

As part of our state license renewal process (every 3 years), we are required to test water samples for lead and copper. Samples are collected from water outlets that a child or staff member have access to. Upon completing this year's sampling it was found that one drinking fountain on the 2nd floor hallway tested above the 15.5 micrograms/liter limit for lead.

While the children do have access to this fountain, *they do not use it*. It has been our standard practice for several years that the children only drink water from our water cooler, which tested below the limit.

This water fountain has been marked Do Not Use and we have spoken to all teachers about this issue.

A possible reason for the higher levels could be lack of use. We will be retesting it ASAP and will provide you the results.

Attached are the full results of this year's testing.
